You assume all risk inherent in the operation and use of the item and agree to assume the entire responsibility for the defense of, and to pay, indemnify and hold Blue Sky harmless from, and hereby release Blue Sky from, any and all claims for damage to property or bodily injury (including death) resulting from the use, operation or possession of the item, whether or not to be claimed or found that such damage or injury resulted in whole or in part from Blue Sky's negligence, from the defective condition of the item or from any cause.
